- 1. Apologies for Absence None
- 2. Vacant Councillor Position The Parish Council co-opted Robert Sculley to the vacant councillor position.

4. Public Participation. The meeting was adjourned to allow public participation

a) A resident of No Man's Heath had organised a petition to support a restricted byway to the definitive map along Salt Street. The petition was handed to the clerk who is to post it to Piers Lindley at Leicestershire County Council. The same resident asked if a dog waste bin could be installed on the main road, raised her concerns about the pot holes on Church Street and that there were roads signs which need to be re-instated following the NO HGV signs being installed. The clerk will raise the issues with the appropriate council.

10. Duckpond

The edging work had been started but it needs a few sandstone kerbs and gravel. SW it to arrange for it to be done.

The lifebuoy still needs to be installed volunteers/arrangements needed.

There is a problem with ducklings being taken by a Heron but as decoys are ineffective alternative plans may be needed. More plants are needed to provide cover although the duck house is being well used.

11. Play Area

As highlighted in the playground report, the matting needs cleaning and volunteers are required. Rob Sculley , along with the help of a resident, will attempt to try and clean it with a brush initially. If this is unsuccessful other arrangements will need to be considered,

The play equipment needs painting, if feasible. RS and a resident will inspect the equipment and see what can be done, while they clean the matting.

The equipment may need changing/updating in the future, but this would depend on grant funding. DC will peak to Steph Wagstaff to see what is available.

12. Field

RS had been approached by a football club wishing to use the field, but the lack of facilities is an issue. There are no showers or changing rooms although there are toilets at the village hall.

A resident asked if the Section 106 funding could be used to provide such sports facilities.

There has been no update from the cricket club regarding the repair of the nets. **ACTION: DC**

13. Village Issues

Newton Regis.

i) The dog sign recently put on the gate in Hames Lane has been removed. The state of the track at the side of the village hall has improved since the dog signs had been installed there.

ii) DC met with C Cllr. Stephen Shaw to discus the issue of the drains/flooding but to date had not had any feedback. DCC is to contact our Member of Parliament to chase the letter, he had received in April, about the flooding issue she had raised with Severn Trent. The Clerk will contact the Highways Department about the flooding.

iii) There is a litter pick planned for Saturday 28th June and DC needs volunteers to deliver the kits and collect the bags afterwards. A request will be posted on the volunteer's site.

There had been no further progress since the last meeting. The preferred option is to tarmac the whole of the car park rather than reactive repairs. The representative for the village hall confirmed that their funding was only available until 30th June.

DCC proposed that the Parish Council commit funds to carry out some sort of repairs to the car park later in the year.

This was seconded by DC and agreed unanimously.
